- If you enter into a contract with GreenZone for cleaning or related services, we may share your information with our sub-contractors and suppliers but only on a need-to-know basis so that we can provide you with an efficient service.
- If you become an employee of GreenZone, we will share your personal information with our external payroll bureau, our pension provider and also the HMRC. We may also share the information with the Disclosure and Barring Service, as some of our clients require staff to hold a current DBS certificate.

# Website Privacy Policy

- If you enter into a contract with GreenZone for daily office cleaning or related services, we will store your information for a period of 6 years after the termination of the contract, unless either (a) the terms of the contract require us to destroy or return whatever information is held at the end of the business relationship (b) you make a request to us to destroy or return whatever information is held.
- If you become an employee of GreenZone, we will store your personal information for 6 complete tax years after the year in which you leave GreenZone. After that time, we will delete your personal information from our computer files and we will destroy all hard copies, unless the types of information fall under statutory retention regulations.
